## CASA

A Court Appointed Special Advocate (CASA) is a trained community volunteer appointed by a judge to speak up for the best interest of abused and neglected children, who have been removed from their home due to abuse or neglect abused, involved in foster care. CASA volunteers make independent recommendations to the court for services which focus on meeting the needs of each child. Dedicated adults willing to volunteer and speak up for abused and abandoned children as they go through our local court system are needed!

### Qualifications

- Sincere care for children
- Mature adult, at least 21 years of age
- Good verbal & written skills and ability to be objective and non-judgmental
- Available to attend all court hearings
- Commitment to CASA for at least 1 year

## Child Advocacy Center

### Collage/Treatment Preparation

Cut out pictures and words from magazines for use in treatment activities. Can be done from home and brought to center.

### Child Care

- Provide care for children whose parents/siblings are in counseling sessions.
- Provide care for children during court sessions.

### Cleaning

Sterilizing and cleaning toys in waiting area.

### Administrative Assistance

Assist with advocacy efforts by supporting staff with data entry, letter writing, phone calls, updating resources information, arranging speaking engagements and other task as needed.

## Development

### Special Events

- Art of Chocolate is our fall fundraiser that features fine food, art, music, and delectable desserts.
- Cookin' For Kids is our spring fundraiser that features a BBQ, wild game and fish cook-off and fun for the entire family.
- Represent Child Enrichment at local events and fairs.

### Clothes Closet

Assist with collection, sorting and distribution of clothes and supplies benefiting CEI clients and area children in foster care.

Stuff, seal and sort mail during November.

### Office Assistance

Assist with answering phones, greeting clients, supervising children, data entry, phone calls and other task as needed.
